group reviewed the revised version of a previous campus policy on alcohol sales and service. Chancellor swa commented that the changes are to provide needed clarity. She reminded the group that in all policies, eral Law supersedes State Law, which supersedes Board of Regents policy, which supersedes Montana e University policy, which provides guidance for MSUB policy. The Board of Regents prohibits alcohol on apus, unless a variance is filed and expressly permitted by the Chancellor.
