John Culbertson, Director of the Carpentry Program, stated that some changes had been made to this proposal before it left the COT, but they did not make it into the paperwork the UCC received. These were small changes in the suggested plan of study and some wording changes. Mr. Culbertson noted they hope to have 10 students in the first semester of this program. Craig McKenzie, Team Leader, noted that the State is attempting to standardize carpentry programs across Montana to ensure students can transfer easily. All the units who will offer or are offering carpentry will try to match their curriculum, but it will not be *exactly* the same program across the state. Mr. McKenzie also noted that the Career Center and the COT have an agreement that COT students will be able to use the Career Center labs and equipment for the first two years, until the new COT building is finished. The COT has a grant to buy equipment for the new program. Mr. Culbertson noted that besides the carpentry emphasis, others can be developed such as plumbing and electrical.
