Brian Gurney, Chair, called the meeting to order at 4:00 p.m. in the Chancellor's Conference Room.

The January 20 meeting minutes were accepted as presented.

I. DISCUSSION WITH SUSAN GILBERTZ, ACADEMIC SENATE CHAIR

Dr. Gilbertz thanked the Committee members for the work that has been done, especially moving items forward as consent. It has been very helpful to the Senate. Regarding the Pharmacy Technician program on last week's agenda and again today, there were lots of questions raised that are legitimate concerns for MSU Billings. However, the responsibility of the UCC is to assess the curriculum presented. Questions about staffing are appropriate. She met with the Senate Executive Committee, and they were in agreement that while non-curricular questions may come up at UCC, the UCC should forward those questions and concerns to the Senate. In relation to the Pharmacy Technician Program, the Senate will thoroughly discuss the Missoula MOU, but at the same time, those are concerns for the administration. The UCC and Senate should focus on the content. How the courses are administered is up to the administration of MSUB. As we work toward offering new programs to recruit and retain students, the Senate will take on the role of discussing whether those programs make sense for MSUB, but not how those programs will be paid for. The program prioritization process will likely become what we do all the time, and it's going to be different than what we have done.

Susan Floyd, Director of Nursing, stated that the current nursing program at City College is six semesters. The students have two prerequisite semesters and then apply to the Practical Nursing (PN) program. There are two semesters in the PN program and then the students can sit for their LPN exams. They may also apply to the Associate of Science in Nursing (ASN) program at this point. Two more semesters in the ASN lead to the students being able to sit for their RN exams.

With the changes presented today, the PN program will be pulled out and separated from the ASN program. Community members have been frustrated that students are skipping the PN program and going straight through to the ASN. Pulling the PN program out will also give students who may be struggling in the ASN a different degree program to choose, if needed. The PN will change from an AAS degree to a Certificate of Applied Science, a three semester program. The Certificate will be offered entirely online, with different, lower-level Gen Eds that include a different anatomy and physiology (A&P) course and a math geared specifically for the PN students. Chemistry and nutrition are out. City College has grant funding to put all the PN courses online and there are five full-time faculty to teach these programs. The ASN will stay with the six semester configuration but the titles and course

descriptions of almost every course will be changed. Students who complete the PN Certificate will have to take twelve credits of Gen Ed to complete the ASN. They plan lot of up front advising with students to decide which program they should pursue.

Once these changes have been approved by the campus, they will go to both the Board of Regents and the State Board of Nursing for approval.
